HOW IT WORKS

1 MATCH

Double Up Food Bucks matches SNAP (Supplemental Nutrition Assistance Program, formerly known as food stamps) benefits at farmers markets across Oregon so shoppers can bring home twice as much fresh produce.



2

DOUBLE

For every dollar spent on SNAP-eligible foods at participating farmers markets, shoppers receive an additional dollar to spend on Oregon-grown fruits and vegetables, up to \$20 per visit.

RESPOND

Double Up is helping Oregon respond to the impacts of unprecedented inflation, ensuring people have access to fresh produce while investing in local farmers & economies.

95% of SNAP participants surveyed reported buying more fruits and veggies because of Double Up

87% of surveyed participants reported that the amount of food they have in their house increased because of DUFB
